Dear Rt Hon. Rishi Sunak MP / Rt Hon. Liz Truss MP

Congratulations on your successful campaign to become one of the final two candidates in the Conservative Party leadership contest. We are writing to urge you to show your support for the government’s 2021 Action Plan for Animal Welfare, and your commitment to passing and strengthening more laws to protect animals from cruelty and suffering.

The Conservative Party’s 2019 manifesto states that ‘high standards of animal welfare are one of the hallmarks of a civilised society.’ We fully agree with this sentiment. We define ourselves as a ‘nation

of animal lovers', with almost three quarters of the public saying that they would like to see the government pass more laws to improve animal welfare.<sup>1</sup>

The manifesto pledged to continue our 'long tradition of protecting animals' and last week we celebrated a major milestone in that history. On 22<sup>nd</sup> July 1822, Parliament passed the UK's first animal protection law, prohibiting certain cruel treatment of cattle and other animals. Two hundred years later we have much to be proud of, but there is so much more to do, both for animals here in the UK and for animals overseas.

Animals need a Prime Minister whose government will give them the legal protections they need and deserve, as sentient beings. Will you pledge such protections as part of your leadership campaign?

The government's 2021 Action Plan for Animal Welfare contains many important measures of which only four have been completed to date. Specifically, will you commit to:

1. **Prioritise time to allow the Kept Animals Bill** to pass in the current Parliamentary session, delivering on manifesto commitments to end live exports for fattening and slaughter; introduce new laws to tackle low welfare puppy imports and pet abduction; and restrict the keeping of primates as pets, amongst other measures.
2. **Progress legislation to protect the welfare of animals abroad**, including bans on imports of hunting trophies, fur and foie gras, and the advertising of low welfare tourism activities overseas, such as elephant rides.
3. **Strengthen existing legislation to:** introduce compulsory cat microchipping; phase out use of cages in farming; prevent inhumane trapping and killing of wildlife (e.g. banning snares and expediting an end to the badger cull); support the Life Sciences sector in an accelerated transition to a goal of ending animal experiments; and, crucially, strengthen and extend the current laws on hunting with dogs.

Animals matter, and our treatment of them matters to voters of all political persuasions. We would be very grateful to receive your views and we will be pleased to share candidates' responses with our supporters and the wider public and press.
